Re: **National Automatic Sprinkler Industry Trust Funds | Reporting and Remittance Procedures**

To All Participating Sprinkler Contractors:

You may have recently received a notice promoting the services of LaborAid.

Please disregard the LaborAid notice and continue to submit reports and contributions for the National Automatic Sprinkler Industry (NASI) Trust Funds in accordance with your collective bargaining agreement and the Funds' *Guidelines for Participation*.

LaborAid has not been endorsed or authorized for use by the Trustees of the NASI Trust Funds.

Moreover, although the communication was distributed on National Fire Sprinkler Association (NFSA) letterhead, it was not authorized or issued by the NFSA.

The Boards of Trustees of the NASI Trust Funds, in their sole discretion, are responsible for determining the form and manner in which monthly reports and contributions are submitted. The Trustees have not approved (or even considered) a change to the current reporting and payment system.

Accordingly, your company should proceed business as usual, and report and pay contributions in accordance with the well-established system, i.e., through the NASI Trust Funds' online portal (NASI EmployerXG) or by mail, by the fifteenth (15th) of the calendar month following the month in which work was performed.

The procedure for reporting and making payments is set forth in the NASI Trust Funds' *Guidelines for Participation*, available on the NASI Trust Funds' website for ease of reference. This is the only procedure approved by the Boards of Trustees for the NASI Trust Funds. **Again, the NASI Trust Funds and the NFSA do not endorse LaborAid, and the notice you may have received regarding LaborAid should not have been distributed.**
