Vacation Plan Payout Checks

The semiannual Vacation Plan disbursements will be processed the second week of April. For those members who have enrolled in direct deposit, otherwise known as Electronic Fund Transfer (EFT), disbursements will be processed on Wednesday, April 7th and the funds should be received in your bank account on file on Thursday, April 8th. For those members who will be receiving a check by mail, checks should be processed and mailed from the Fund Office by Friday, April 9th. You should receive the check by Friday, April 16th, at the latest.

Please remember, you may enroll at any time to have your benefits paid by the Fund Office through direct deposit. To enroll in direct deposit, you can find the EFT Authorization Form online at www.steamfitters.com in the Forms section or call the Fund Office at (212) 465-8888, option 9 to be mailed a copy of the form. To enroll in direct deposit directly on the member self-service link, go to www.steamfitters.com and select Construction Trades Benefits and click on "Member Login".

2021 National Preferred Formulary Exclusions List Update

Express Scrips has added 32 medications to its National Preferred Formulary (NPF) Exclusion List effective April 1, 2021. For reference, there are well over 20,000 drugs approved by the FDA. A very small number of participants or dependents were affected by this April 1st update. Each affected person was notified in March to contact Express Scripts so that they could be educated about an alternative drug their physician or health are provider could prescribe. Drugs or supplies on the Exclusion List are not covered and you would pay full retail price for one if you filled a prescription. You can view the April 1, 2021 additions to the NPF Exclusion List as well as an entire NPF Exclusion List by accessing https://www.express-scripts.com/2021drugs. Weight Management Care Value Program Newest Program to Address The Growing Crisis of Obesity

Commencing on May 1, 2021, the newest care value program in the Express Scripts' SafeGuardRx roster will work with participants and dependents to battle obesity. 40% of American adults are obese and that percentage is predicted to climb to 50% by 2030. Over 21% of all hospital and medical spend nationally is for obese-related illnesses. Obesity leads to poor mental health and a reduced quality of life.

The Weight Management Care Value Program (WMCVP) is completely voluntary. Express Scripts will contact a participant or dependent directly to enroll in the program if they qualify based on their use of the anti-obesity drug Saxenda. Additional anti-obesity drugs may be added in the future. Specially trained clinicians from the Express Scrips' Therapeutic Resource Center will work with those that are enrolled. The program embraces a Digital Obesity Solution which includes a cellular-connected scale, personalized coaching from registered dieticians, an individualized behavior-based weight loss program, App-based peer support and more.

Notification of Divorce Timely Notification is Imperative

Keeping the Fund Office up to date regarding changes in your life is important. In the event of a divorce, it is imperative for the Fund Office to remove any dependents from coverage whom we should no longer include on premium payments, in order to prevent the utilization

of ineligible benefits, to offer COBRA coverage within 60 days from the date of divorce (required by law) and to avoid delaying a prospective retirement process. **Please be aware participants are financially liable for the costs the Welfare Fund incurs due to your non-notification.**

To report a divorce to the Fund Office immediately upon its completion call the Welfare Fund at (212) 465-8888, menu option 4. You will be instructed to submit a full copy of your judgment of divorce document. If your divorce document is not yet available from the court or municipal clerk, you will be required to complete a pre-printed affidavit.

In order to prevent any delays in your prospective retirement process the Pension Department requires the following divorce documentation to determine whether your former spouse is entitled to a portion of your benefits from the Pension Plan: Judgment of Divorce, Settlement Agreement or Stipulation of Settlement, Findings of Fact and Conclusion of Law. You will be required to furnish these documents when you apply for your retirement benefits. If at that time it is determined that a former spouse is entitled to a portion of your Pension benefits and we do not have the appropriate records on file, it will delay your retirement.

You should also report events such as a change of address, a new spouse, a birth, adoption of a child, your entrance or discharge from military service, disability and changes to your beneficiaries.

Thinking About Retirement?

If you are thinking about retirement, we encourage you to make an appointment to schedule an interview with the Pension Department. If you already know when you want to retire, be sure to contact the Pension Department at least 3 months prior to your retirement date in order to



receive your pension application materials. The application must be completed at least 30 days, but no more than 180 days prior to the effective date.

Also, please be aware that the Pension Fund must verify your age and your legal marital status when you apply for retirement. Make sure to have documentation for you and your spouse; if you are married. Acceptable documents for date of birth and/or marriage are: birth certificates, passports, baptismal certificates, immigration or naturalization papers, marriage certificate and/or a marriage license. If you do not have any acceptable documentation, you should obtain copies of these prior to submitting your retirement application.
