FRAUDULENT CLAIMS: IT'S NOT WORTH LOSING YOUR BENEFITS

The submission of fraudulent claims is an extremely serious matter. All claims are randomly reviewed and audited for accuracy including verifications with the providers and suppliers. Claims for supplemental unemployment are verified on a retroactive basis.

If you are found to have filed a fraudulent claim with any of the Welfare Funds, Health Reimbursement Account, or the Security Benefit Fund you will be suspended from participating in those funds for a period of one year. Should you be involved in a second or third offense your suspension will be more severe.

Your benefit programs are here to help you. Don't be foolish and misuse them.

PENSION PLAN AMENDS RULE

As of July 1, 2010 the following will became effective:

▶ The period of time in which a participant can apply for a pension will be expanded. A completed application for pension benefits must be submitted to the Fund at least 30 days, but no more than 180 days, before the date the participant wishes to retire.

HEATHCARE REIMBURSEMENT ACCOUNT OTC MEDICINES AND DRUGS TO LOSE REIMBURSEMENT

As of January 1, 2011, the reimbursement of over-the-counter (OTC) medicines and drugs will no longer be permitted unless the medicines or drugs are prescribed by an appropriate health care provider.

The new reimbursement rules go into effect for expenses incurred on or after January 1, 2011. This new regulation will have no effect on the reimbursement of co-pays from Medco for prescription drugs.

This change was mandated as part of the Patient Protection and Affordable Care Act and the Health Care and Education Reconciliation Act. These two pieces of federal legislation, together, are commonly referred to as the new national health care reform law.
