## Vacation Plan Payout Checks The Semiannual Vacation Plan Payout checks will be mailed

or direct deposited on October 10th. Please remember, you may enroll to have your benefits paid by the Fund Office through direct deposit or otherwise known as Electronic Fund Transfer (EFT). Over 500 Steamfitters received their payout via EFT in April. If you are already enrolled, your payout should be in your bank account on October 10th.

## Supplemental Retirement Plan Investment Changes



The United Association S&P 500 Index Fund is ceasing operations and will no longer be available for contributions effective October 21, 2013. All existing and future contributions in this fund will automatically be transferred to the new investment option, the Columbia Large Cap Index Fund, on October 24, 2013. You should have already received correspondence with more details in a communication from New York Life Retirement Plan Services regarding this change. If you have any questions or you do not want your existing balances and future contributions to transfer to the investment option above, you may request a transfer *before* 4 p.m. ET on October 24, 2013. ## Retired Participants Receiving a Disability Pension Benefit

Shortly, you will be receiving "Your New Benefit Amount" letter from the Social Security Administration (SSA). You will be required to submit a copy of this letter to provide proof of your continued receipt of Social Security disability benefits when the Pension Fund conducts its annual audit. Please send the letter you receive from SSA to the Fund Office or make sure to keep it until you receive our Annual Audit letter requesting the same. If you have any questions on this subject please call the Fund Office at (212) 465-8888, menu option 3 for the Pension department.

## Return to Work Pensioners

If you have a minimum of 750 hours earned in 2013 you are eligible for an additional year of Pension credit. An additional Pension credit for 2013 becomes payable effective February 1, 2014 at the earliest. For an application, contact the Fund Office at (212) 465-8888, menu option 3 for the Pension department. Your application must be submitted at least 30 days prior to your benefit effective date. As an example, if your effective date is February 1, 2014, a valid application must be received no later than January 1, 2014.



## The Women's Health and Cancer Rights Act (WHCRA)

Do you know that your plan, as required by the Women's Health and Cancer Rights Act of 1998, provides benefits for mastectomy-related services including all stages of reconstruction and surgery to achieve symmetry between the breasts, prostheses, and complications resulting from a mastectomy, including lymphedemas. Such coverage may be subject to annual deductibles and coinsurance provisions as may be determined and are consistent with those established for other benefits under the plan or coverage.

# Keep Your Pay Stubs

Please review your pay stubs against your Statement of Earnings each quarter. # Remember to get your Flu Vaccination!

Stay flu-free with these vaccination facts:

Who should get a flu vaccination?

Anyone wanting to reduce their chance of getting the flu. This is especially true if you:

- Are age 50 years or older
- Are pregnant • Live with or tend to
- young children
- (0 23 months of age)
- Live with or tend to a "high-risk person"
- Have a chronic medical condition

Who should NOT get a flu vaccination?

Some people should not be vaccinated without first consulting a physician, including:

- People with allergies to chicken eggs
- People who have had a severe reaction to a flu vaccination in the past
- Children less than six months of age · People who developed Guillan-Barre syndrome (GBS) within six

weeks of getting an influenza vaccine · People who are mildly or severely ill should wait until their symptoms lessen before getting a flu vaccination

When should you get a flu vaccination?

Flu season can begin as early as October and last through May. October or November is the best time to get vaccinated, but even after December is not too

late. Your doctor can tell you the best time to get a flu
