## **ELIGIBILITY FOR OFFICE – U.A. CONSTITUTION**

**Section 121.** "No member shall be eligible to be nominated for office in any Local Union unless he/she shall be a journeyman member and shall have been a member of the United Association and the Local Union in good standing for at least a period of two (2) years immediately prior to the election. Any journeyman member who owes or has paid a reinstatement fee within a period of two (2) years immediately prior to the date of the election shall not be eligible to be nominated for office in any Local Union." See Section 161 regarding eligibility of member contractors.

**A MEMBER NOMINATED MAY ONLY ACCEPT THEIR NOMINATION BY BEING PRESENT AT THE NOMINATION MEETING, OR BY A LETTER OF ACCEPTANCE THAT IS RECEIVED PRIOR TO THE NOMINATION MEETING IN THE EVENT THE MEMBER SEEKING NOMINATION IS UNABLE TO ATTEND. A LETTER OF ACCEPTANCE OF THE NOMINATION MUST BE RECEIVED IN THE OFFICE OF LOCAL 343 PRIOR TO THE NOMINATION MEETING.**

## **ELIGIBILITY TO VOTE AT ELECTION – U.A. CONSTITUTION**

**Section 124 (a).** No member shall vote at any election of any description unless he/she has been a member in good standing in the Local Union where the vote is being taken for a period of one (1) year immediately prior to the date of election. Any member who owes or has paid a reinstatement fee within a period of one (1) year immediately prior to the date of election shall not be eligible to vote in any Local Union Election." See Section 161(a) regarding eligibility of contractor members to vote.
