Dear Local 638 Member:

As you may know, the following eleven individuals—including former officials of Local 638—were charged with bribery and labor offenses in United States v. Cahill et al., 20 Cr. 521 (CM).

The crimes charged arise out of the defendants' acceptance of bribes and illegal payments in connection with their positions within Local 638 or other union organizations during the period October 2018 through October 2020.

As a member of Local 638, **you have a right, under federal law, to attend and participate in court proceedings in this case, including plea hearings and sentencings.** The following court proceedings are scheduled to take place:¹
